GRANT TOWNSHIP BOARD
FEBRUARY 9, 2021

Regular meeting of the Grant Township Board called to order by Supervisor Dysinger. Board members present: Dysinger, Teall, Shea, Bell, Kunse. 6 guests present. Pledge of Allegiance recited.

f. The board discussed the proposed detour route desired by MDOT for preparation of overpass work on Leaton Rd and US10 expressway in 2022. We would like to improve the N. County Line Rd. (Clarabella) from Cornwell west to old US10 in 2022. There is bridge/box culvert work also needed on this stretch. (Herring/Murphy drain) CCRC would like financial assistance on the bridgework. Bruce Tiedeman wanted to know if Shamrock Lake will be dredged before any work is done on roads and bridges. Karl Randall wanted to know about the cost to the township. Supervisor Dan Dysinger said we are still waiting on estimated costs for that.

g. **PUBLIC COMMENT** John Urqhart wanted to know if there was any talk about the bridge on Surrey Rd. Supervisor Dan Dysinger assured that the bridge will be completed before paving, Dysinger will be talking with CCRC Al Leonard about the bridge being too narrow.
